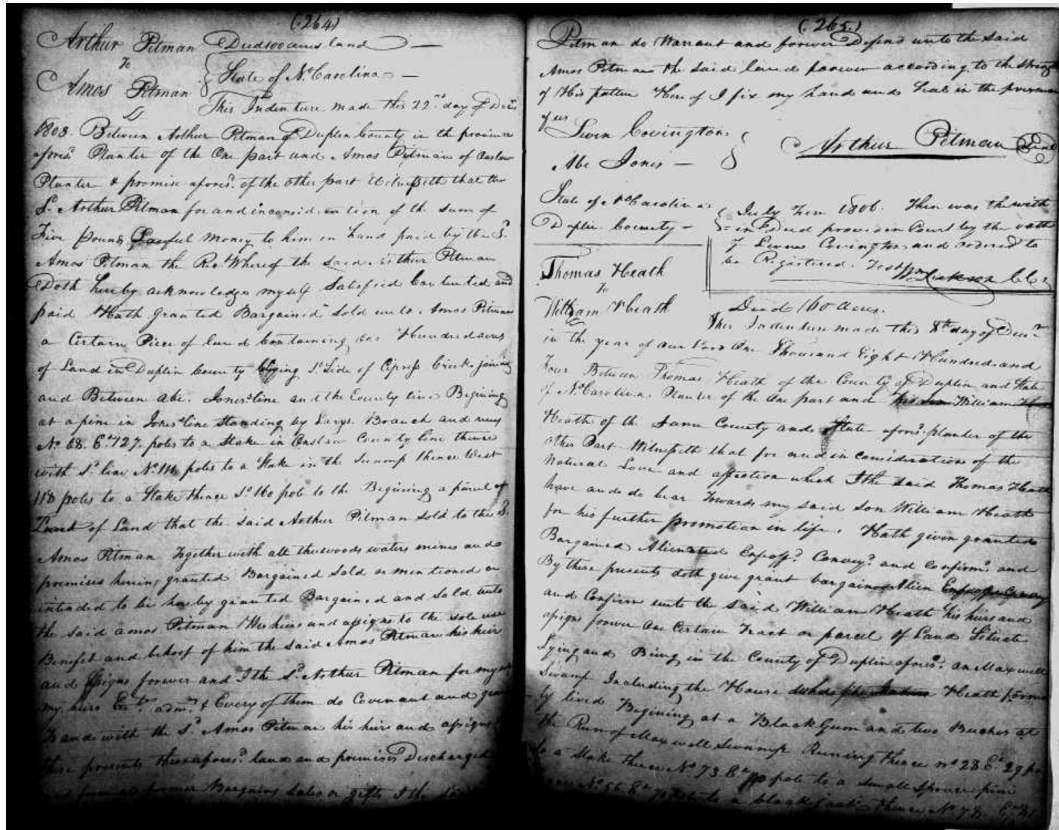
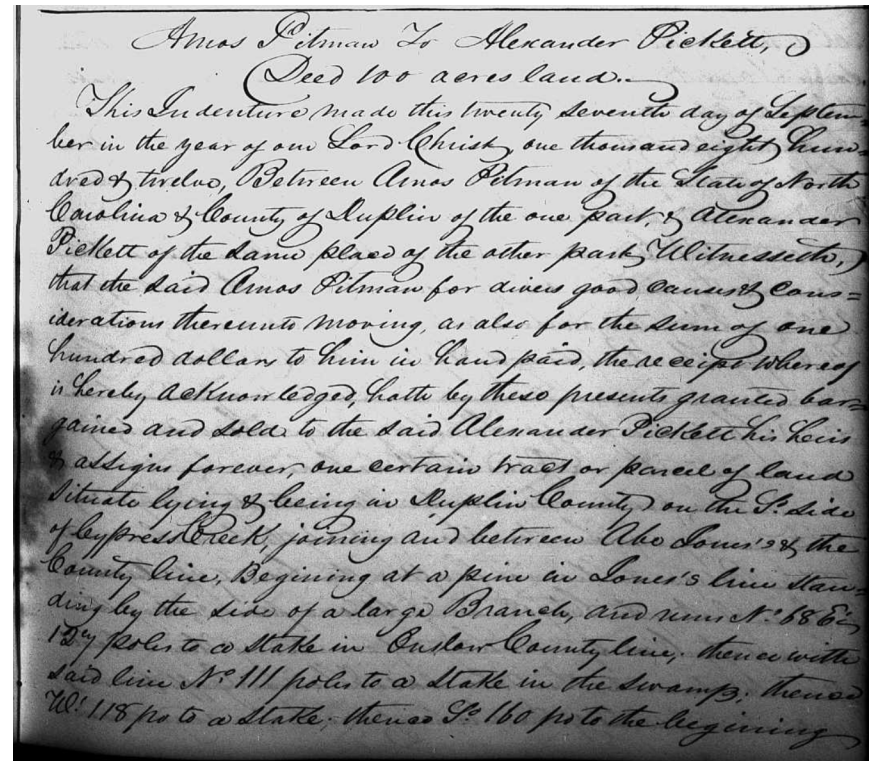

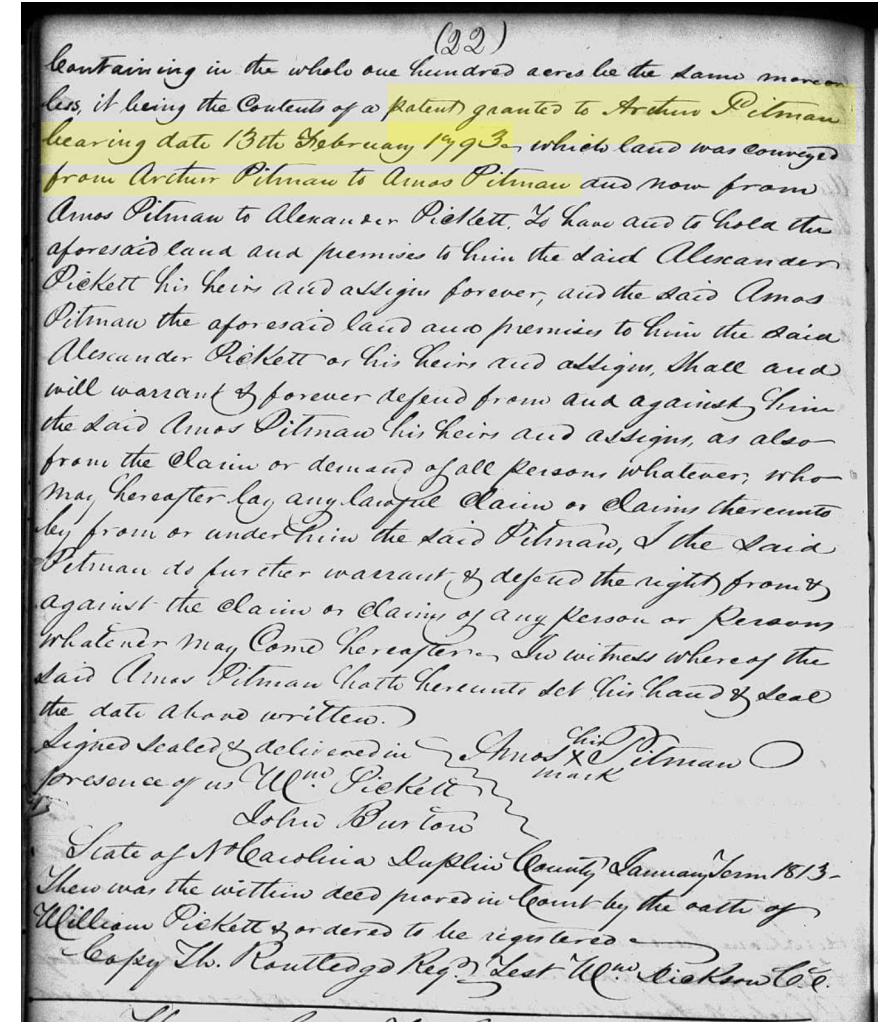


This land in Duplin County was acquired in 1793... as shown in the Deed to his apparent son Amos.
